

Overview

This release introduces valuable enhancements to AllyIQ's IMS, with a focus on Dispense, Restock, Order management, and Reporting. These updates improve workflows, enhance data accuracy, and offer more granular control over inventory, providing users with greater insight across the platform.

Enhancements

- **Dispense:**
 - On-Demand (Manual) Dispense: Unlike *Appointment*-based dispensing, which requires a scheduled visit, On-Demand dispensing provides a product based on immediate need, without requiring a prior appointment. *Disclaimer: Please continue to follow your organization's protocol(s) and note that a provider's order should still be necessary to proceed.
 - History: Dispense History now includes both *Appointment* and *On-Demand* transactions that enables users to view a complete record of Dispense activities, whether tied to a scheduled *Appointment* or initiated *On-Demand*.
- **Restock:**
 - History: Ability to View Details for Damaged Products – Users can access information under History for products labeled as "Restock Type: Replace Damaged," improving visibility and tracking of damaged inventory. For products that are Partially Restocked, the system will show the latest Restocked Date.
 - Restock from Orders: Add Replaced – The Replaced tab has been added enabling users to easily view items that were replaced due to a *Damage Type* selected during the workflow. The tab will display item details in a view-only format.
 - Manual Restock: Guidance for Price on Purchased Products – During Manual restock of *Purchased* products, users will be informed if a price is required. However, if a price has already been entered, the user can proceed without interruption.
 - Manual Restock: Add Reference Number – "Add Reference Number" field, supporting up to 30 characters, has been added to Manual Restock entries, allowing users to track and reference transactions more efficiently.
- **Order:**
 - Price Information Display – Price information for "Orders" has been optimized, ensuring users receive the most accurate and consistent pricing data.
 - Display "Replaced" Tab on Partially + Fully Restocked Order – When a *Damaged* product is *Replaced*, and the user navigates to the Order Details page: A "Replaced" pill will display with the count of *Replaced* items. If the quantity of *Replaced* items equals *Damaged* items, the "Damaged" pill will not appear.

- **Transfer:**
 - Prevent Duplicate Item for Transfer – The system now prevents users from adding duplicate products within a Transfer. If a duplicate is detected, an error message will prompt the user to scan a different item.
- **Daily Dispense Report:**
 - Reporting: Dispense Report Includes Treatment Area – The Dispense Report has been updated to include the Treatment Area for each dispense entry, providing users with additional information by showing the specific treatment area associated with each transaction.
- **Formulary:**
 - PF: Source: Price Information Display and Update – Price information for Source(s) within the Practice Formulary has been updated, ensuring users have access to accurate and up-to-date pricing.
 - PF: Source - Sort by Alphabetical Order – The “By Source” tab now features alphabetical sorting, streamlining the process of finding and navigating products by *Source*.
